**Public Act No. 09-81** - AN ACT CONCERNING GREEN CLEANING PRODUCTS IN SCHOOLS exempts any disinfectant, disinfecting cleaner, sanitizer or any other antimicrobial products regulated by the federal Insecticide, Fungicide and Rodenticide Act. These products are considered exempt and are listed below:
